# Background

The Australian Melanoma Foundation (AMRF) is a not-for-profit charity established in 2006 by a group of dedicated volunteers to provide funding for melanoma research, awareness and early detection program.

The AMRF now provides grants each year for two categories of researchers - to assist post-graduate students in the field of melanoma and to support young scientists with novel ideas for melanoma research.

Since 2006 we have provided nearly \$0.5m for research projects aimed at furthering knowledge and offering better outcomes in the prevention, diagnosis and treatment of melanoma.

A total of 17 research projects have been supported by the AMRF since its inception. The Foundation's first grants co-funded research conducted at the University of Adelaide on the use of immunotherapies to treat melanoma.

AMRF is a registered charity with the Australian Charities and Not-for-profits Commission (ACNC) and is endorsed as a Deductible Gift Recipient (DGR) with the Australian Tax Office. In addition to bequests, we accept donations at any time. Donations made during your lifetime over \$2 are tax deductible.

# Making a bequest

Bequests are meaningful gifts you can include in your Will to support causes you care about. Making a bequest is a simple and impactful way to leave a lasting legacy.

If you are interested in including a bequest to support AMRF, we are here to help. Below are some example clauses to help guide you in drafting or updating your Will. However, we strongly encourage you to consult with your legal adviser before making any decisions.

These clauses are examples only and do not constitute legal advice. Your generosity will make a big difference in funding melanoma research, awareness and early detection programs.

#### **Example Bequest Clauses**

### Example One - A percentage of your estate

I give to the Australian Melanoma Research Foundation ABN 26 429 861 213 ("AMRF") [insert %] of my estate to be used for the general purposes of the AMRF. I declare that the receipt of an authorised officer of the AMRF will be sufficient discharge to my Trustee, who will not be bound to see to the application of this gift.

## Example Two – A specific amount of money

I give to the Australian Melanoma Research Foundation ABN 26 429 861 213 ("AMRF") the sum of \$[insert amount] to be used for the general purposes of the AMRF. I declare that the receipt of an authorised officer of the AMRF will be sufficient discharge to my Trustee, who will not be bound to see to the application of this gift.

### Example Three - The residue of your estate

I give to the Australian Melanoma Research Foundation ABN 26 429 861 213 ("AMRF") the residue of my estate to be used for the general purposes of the AMRF. I declare that the receipt of an authorised officer of the AMRF will be sufficient discharge to my Trustee, who will not be bound to see to the application of this gift.
